#### **US Funding Cuts & Legal Environment Shifts**

- <u>At least</u> \$12 billion in cuts from USAID contracts representing <u>24-53%</u> of USAID's total work.
- New policies, executive orders and government memos resulting in an more restrictive fundraising and operating environment for philanthropy and civil society.
- <u>Global health</u> (especially <u>SRHR</u>), gender equality and humanitarian work likely to be heavily hit.
- Sub-Saharan Africa likely to be the most impacted region
  - historically, the largest regional recipient of US funding
  - newly-proposed <u>elimination</u> of State Dept bureau of African affairs



## **High-Level Trends: Global ODA Cuts**

In 2024 –even before the Trump Administration took power– 7 wealthy countries + EU announced \$17.2b in cuts to ODA, all to take effect\* over the next five years, including:

- Germany
- France
- Sweden
- Netherlands
- Finland
- Norway
- Switzerland
- EU



\*While we know cuts are likely to be severe and disruptive, the nature, volume, and thematic/geographic implications of these cuts are not necessarily determined or final as of today.

Strategic advocacy or future electoral shifts may further shift the nature of these cuts from some countries more than others.



## **High-Level Trends: ODA**

- Increasingly seen as a tool for **delivering domestic priorities**
- Increasing **ODA spent domestically** on refugee costs
- More **power shifting out of development ministries** and bureaucracies
- Defense spending going up with likely further cuts to ODA
- Only 1% of total ODA goes directly to CSOs as core support and
  0.1% goes directly to CSOs in the Global South (OECD data)
- Estimated annual **gap of ODA for human rights of \$1 billion by 2027** (HRFN)



### **Philanthropic Response**

- Philanthropic coordination gaining momentum
  - Emergency grants and flexibility
  - Increased endowment payouts
  - Meet the Moment Pledge & Council on Foundations Statement
- **Chilling effect in the US**; culture of fear, mitigation, and deference to legal teams, heightened by threat of new Executive Orders regarding tax status. Some consideration of moving assets out of the US.
- Many **large foundations still waiting** to get more official clarity on the final "landing place" of changes
- **Corporate giving in the US seems to be slowing down** (at least temporarily) in response to change in political environment + increasing caution around tariffs
